## ORDINANCE NO. 399

AN ORDINANCE BY THE CITY COUNCIL FOR THE CITY OF BROKEN BOW, OKLAHOMA, PRESCRIBING MAXIMUM FINES FOR THE MUNICIPAL COURT NOT OF RECORD FOR THE CITY OF BROKEN BOW, OKLAHOMA, REPEALING ALL ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH, AND ESTABLISHING AN EMERGENCY.

WHEREAS, Oklahoma law pursuant to 11 O.S. §14-111 allows the governing body of a municipality having a municipal court not of record to enact ordinances prescribing maximum fines pursuant to the provisions of subsection C of said statute.

WHEREAS, the governing body of the City of Broken Bow desires to prescribe such a fine schedule.

Be it ordained by the City Council of the City of Broken Bow, that the provisions of this ordinance shall become and be made a part of the code of ordinances of the City of Broken Bow, Oklahoma and the sections of this ordinance may be renumbered to accomplish this intention.

The following schedule of maximum fines is prescribed:
